

2019 Cost-of-Service Rates & Charges

Following the public hearing during its regularly scheduled November 2018 board meeting, the Castle Pines North Metro District Board of Directors approved minimum, but essential, cost-of-service adjustments for on-demand delivery of water and wastewater services. These cost-ofservice adjustments will take effect beginning January 1, 2019:

- 3% increase in water service rates
- 4% increase in wastewater usage charges
- 0% increase in storm drainage charge
- 0% increase in the capital maintenance charge
- 0% increase in the renewable water fee

What will these adjustments mean for your monthly 2019 water bills?

- Due to the change in rates and charges, the average residential combined water, wastewater, and storm drainage bill will increase \$5.75.
- Due to the change in rates and charges, 94% of the residential water, wastewater, and storm drainage bill will reflect an increase of \$8.00 or less.
