

## Public Hearing on Proposed 2019 Cost-Of-Service Rate/Fee Increases Now Accepting Board-Vacancy Applications

November 12, 2018

Dear Neighbor:

We invite you to join us for our board meeting at 6:00 p.m., on November 19, 2018. Among the items on our agenda that night will be two important updates: the first, from Bartle Wells Associates on the District's recent **Water**, **Wastewater**, **and Stormwater Rate Study**; and the second, from Pinnacle Consulting Group on its proposed **2019 Budget** for the District.

As part of our annual budget process, immediately following the above-referenced updates, we invite all residential and commercial customers to participate in a **Public Hearing** regarding our **consideration of modest 2019 cost-of-service rate/fee increases**. If approved, the adjustments would likely take effect beginning on January 1, 2019.

In the spirit of full disclosure, the District is facing 2019 cost-of-service water and wastewater rate/fee increases of between 3% and 4%. As fiscal conservatives, please know that we dislike considering rate/fee hikes as much as we — and you — dislike paying them. As part of our deliberative process, we scrutinize closely all proposed rate/fee increases. Rest assured that our consideration of any proposed rate/fee adjustment would be the result of unavoidable cost-of-service and/or inflation expenses. (**NOTE:** cost-of-service equals all costs to finance, design, build, operate, and maintain the system and deliver the service.) In the absence of a fiscally responsible alternative, we think it wise to *consider* modest annual rate/fee increases and thereby avoid the erratic toggling back and forth between no rate/fee increases in some years and double-digit increases in others.
