INFORMATION

- All rebate requests must be accompanied by this request form, and by a copy of the applicable sales receipt and a picture of the installed item. Rebates will appear as an adjustment on your water bill.
- Rebates are available for property owners only. Renters of property in Castle Pines are not eligible.
- Rebates are not retroactive for previous adjustments or additions.
- Participants in this Rebate Program understand "rebate funds" are limited for this program, and funds are on a first-come, first served basis; and in no terms is the participant guaranteed a refund in this program.
- Participants understand this Rebate Program is for the cost of approved devices only. Installation costs are not covered.
- Metro District staff may schedule an appointment to inspect the new fixture(s) after installation.
- In no case will the rebate amount exceed the purchase price.
- Rebates for evapotranspiration controllers, sprinkler heads, rain sensors, toilets, and shower heads will apply to replacement items only. There is a one time rebate per household.
- Residents are strongly encouraged to have landscape designs pre-approved. There is no guarantee that rebate applications for sod removal will be approved otherwise. Designs must contain a minimum of roughly 50% ColoradoScape plant material.
- Old toilets must not be sold for reuse.

REBATE TYPE *(Check all that apply)*

- ☐ **Rotator Sprinkler Nozzles**
Water-efficient nozzles deliver streams of water that reduce evaporation loss. Rebate: up to \$5 per nozzle; replacement only. (Limit 20 nozzles per household or 200 nozzles per HOA or Commercial.)
- ☐ **Rain Sensors**
Detects rainfall and overrides irrigation system. Rebate: Up to 50% of the purchase price (maximum \$50). Limit one per household.
- ☐ **Smart Controller (Residential)**
Regulate irrigation based on temperature, rainfall and humidity. Rebate: \$100 rebate for a Water Sense Labeled Smart Controller.

Additional Discount: Order from Rachio for a discount on 8 or 16 zone controllers (one purchase per house. Also eligible for CPNMD rebate).
- ☐ **Smart Controller (Commercial/HOA)**
Regulate irrigation based on temperature, rainfall and humidity. Rebate: \$100 rebate for Water Sense Labeled Smart Controller (Limit of 5).
- ☐ **Sod Replacement (Residential)**
Replace sod with water-wise plants or low-water turf/ material (xeriscaping). \$3.00/sq. ft. for ColoradoScape, \$1.50 for low-water turf: (i.e. DogTuff, Tahoma 31).

Projects must convert a minimum of 250 sq. ft. of turf to qualify for rebate and contain at least 50% healthy plant material. Maximum of 4,000 sq. ft. eligible for rebate (1 rebate per account/year).
- ☐ **Sod Replacement (HOA Commercial)**
Replace sod with water-wise plants or low-water turf/ material (xeriscaping). \$2.50/sq. ft. for ColoradoScape, \$1.50 for low-water turf: (i.e. DogTuff, Tahoma 31).

Projects must convert a minimum of 1,500 sq. ft. of turf to qualify for rebate and contain at least 50% healthy plant material. Maximum of 15,000 square feet eligible for rebate (combined ColoradoScape, low- water use turf, and impervious areas) (1 rebate per account/year).
- ☐ **Water Efficient Showerhead**
Uses 1.5 gallons per minute or less versus 4 gallons per minute. Rebate: \$10 per showerhead. Limit 4 per household; replacements only.
- ☐ **High Efficiency Toilet Rebate (Residential)**
Use less water with a ultra-high efficient MaP (Maximum Performance) Premium toilet rated at 0.8 gallons per flush or less. Rebate: \$100 per toilet. Toilets must be MaP Premium listed (not dual models). Limit of 3 rebates per household.
